4 Section 5. The Illinois Insurance Code is amended by 47
5 adding Section 356z.1 as follows: 49

6 (215 ILCS 5/356z.1 new) 52

7 Sec. 356z.1. Prenatal HIV testing. An individual or 54
8 group policy of accident and health insurance that provides 55
9 maternity coverage and is amended, delivered, issued, or 56
10 renewed after the effective date of this amendatory Act of 57
11 the 92nd General Assembly must provide coverage for prenatal 58
12 HIV testing ordered by an attending physician licensed to 59
13 practice medicine in all its branches, or by a physician 60
14 assistant or advanced practice registered nurse who has a 61
15 written collaborative agreement with a collaborating 62
16 physician that authorizes these services, including but not 63
17 limited to orders consistent with the recommendations of the 64
18 American College of Obstetricians and Gynecologists or the 65
19 American Academy of Pediatrics.
